## Parent Agreement Statement

I/We have read the enrollment/membership information and understand the following:

- 1) The \$75.00 Registration Fee is non-refundable; It is \$75 for each child with a family cap of \$150;
- 2) The enrollment process is based upon a priority schedule. In some cases, a lottery may need to be held;
- 3) All forms become the property of PNS and will not be copied or returned to a family for any reason;
- 4) At a later time, I/we will receive school forms. When the forms are submitted, I/we will be required to pay a tuition advance equal to the May 2020 tuition, plus one-half the annual materials fee. If the tuition advance and materials fee payments do not accompany the school forms by the stated due date, my child's name will be removed from the class roster. The first child on the waiting list will be entitled to the opening;
- 5) If we are a NEW family, in order to guarantee a spot in the desired class, my May 2020 tuition advance and one-half the materials fee are due by March 1, 2019. If the tuition advance and materials fee payments are not received by this date, my child's name will be removed from the class roster.

In the event of voluntary withdrawal, the tuition advance and materials fee will be refunded only in the following circumstances:

- If withdrawal occurs prior to the first day of school, members must give written notice by July 1, 2019 to the Vice President of Membership/Enrollment to receive a full refund of the tuition advance and materials fee. **No refunds will be given after July 1, 2019.**
- If a family must withdraw from the school during the school year due to extenuating circumstances, they must submit written notice to the Vice President of Membership/Enrollment as soon as possible, explaining the situation and they may request a refund. The Board of Directors will then vote as to whether a refund will be granted.
